

Connecting SL6+ with KCE Cable

- Remove cable from COP F2KMUL J2 and connect to KCE connection board.
- 2. Connect cable from KCE connection board to COP F2KMUL
- 3. Connect: Red: Button


Yellow: Pictogram yellow Green: Pictogram green

Grey: GND

- Splice voice station cable to SL6+ and KCE connection board ground.
- 5. Connect to SL6+ plug B: Orange: +12 V DC Grey: GND Brown: Bus A


Brown: Bus A Blue: Bus B

6. Connect 230 V AC to SL6+ plug F from X13

- 1. Remove cable from COP F2KMUL J2 and connect to KCE connection board.
- 2. Connect cable from KCE connection board to COP F2KMUL

3. Connect:

Green: Button

Brown: Pictogram yellow - Cable 13 White: Pictogram green - Cable 13

Pink: GND


4. Connect:

Brown: Telephone line White: Telephone line

5. Connect to Power Supply:

Pink: GND

Grey: 10-30 V DC
